

Dear Sir or Madame,

The Wisconsin Geographic Names Council has received a proposal to name or change the name of a geographic feature that falls within the Town of Carlton. Local opinion and support is highly valued by the Wisconsin Geographic Names Council when making naming decisions, therefore we are seeking your input with this correspondence.

Below you will find a geographic name proposal summary. I can provide the official proposal form and case documents upon your request.

Recommended Name of Feature: Mishicot River (40.99 mi)
Current Name of Feature: East Twin River (WBIC 84000)

Location & Description: Location (at headwater) T23N R23E Sec 28; Town of Montpelier, Kewaunee County. Location (at mouth) T19N R24E Sec 1; City of Two Rivers, Manitowoc County.

The feature is a 40.99 mile long river flowing south and south east joining with the West Twin River before emptying into Lake Michigan. The river winds through several municipalities in both Manitowoc and Kewaunee Counties. There are no other waterbodies with the name "Mishicot" in the state.

Proponent: Jim Sustman - Rivers Name Change Committee of Manitowoc County, Mishicot, WI

Summary: The proponent wishes to restore the native name of this river, Mishicot, which he feels has more historic and cultural significance than the current name of East Twin. The river was originally named Mishicot after a local leader of the indigenous people living in the area and was used by the native population and European settlers. By renaming the river the proponent hopes to increase the appreciation and concern about the natural environment surrounding the river as well as show respect and improve the relationship with the native tribes who were originally settled there.
